RATES Rates are based on admission charges per person (Season pass holders are free of charge) plus an additional \$20 + HST for rental. Payable by visa, mastercard, interac, or cash on the day of the photo shoot.

Murphy's Farm Market & Bakery reserves the right to cancel the reservation. Murphy's Farm Market & Bakery is not liable for acts out of its control that affect the shoot, such as building equipment failures, power outages, weather, or emergencies. In all cases, the Photographer and family will be given, in Murphy's Farm Market & Bakery's sole discretion, the possibility to reschedule the event.

LENGTH OF USE Will be pre-arranged at the time of the booking. The photographer must arrive during opening hours in order to review what is permitted and sign the contract. Normally opening hours are from 9:00am to 5:00pm however they are to be confirmed. No prior drop-off and/or pick-up after completion of shoot, of equipment, props, etc. unless negotiated at time of rental contract. Additional fees may apply.

ELECTRICAL USAGE Is not included and not easily available.

CLEANING & TRASH Photographer and family agrees to leave the premises (land, crops, buildings, equipment) in the same condition as they were when they arrived. All items brought to the Premises are to be removed by the Photographer and family. Items left after 7 days will be assumed abandoned and may be discarded with no compensation due.

FARM RULES

- No smoking whatsoever anywhere on the premise.
- No alcoholic beverages or non-prescription or illegal drugs.
- Noise is to be kept at reasonable levels and not contain vulgar or offensive words.
- No pets or animals allowed.
- No climbing on working farm equipment (only tractors on display in play yard are acceptable).

CONDUCT Murphy’s Farm Market & Bakery customers have priority in all situations. The Photographer and family shall not block them from going about their visit in any way in order to take photographs. The photographs shall not have any inappropriate content (nudity, vulgar, offensive). The Photographer will not take photographs of Murphy’s Farm Market & Bakery customers or staff without their approval. Photographer shall be solely responsible for the conduct and welfare of all persons accompanying Photographer while on Murphy’s Farm Market & Bakery’s premises. Photographer agrees that a Murphy’s Farm Market & Bakery representative may be present at any time. If the representative observes or otherwise becomes aware of dangerous, pornographic, illegal or negligent practices or activities, the representative reserves the right to stop the shoot and may require Photographer and Photographer’s party to leave immediately. In such case no refund will be given. However, Murphy’s Farm Market & Bakery and its representatives assume no responsibility to act in such cases.

USE OF LOGO AND NAME Photographer agrees that by using Murphy’s Farm Market & Bakery logo and name, they will not defame or otherwise discredit the products or services of Murphy’s Farm Market & Bakery or its officers, employees, partners, affiliates, customers, vendors or other third parties (including our competitors).

AREAS ALLOWED Photographer will be given, in Murphy’s Farm Market & Bakery’s sole discretion, the possibility to take pictures in the store, parking, play yard and fields owned by Murphy’s Farm Market & Bakery. The Photographer will be informed if some areas are restricted.

WAIVER OF LIABILITY Use of Murphy’s Farm Market & Bakery’s premises is at the family’s and photographer’s own risk. The family and Photographer hereby agrees that Murphy’s Farm Market & Bakery will not be held liable for any direct, indirect, incidental or consequential damage, injury or loss to people or possessions while on the Premises. The family and Photographer holds harmless and indemnifies Murphy’s Farm Market & Bakery and its owners, agents representatives, associates, officers, employees, guests and tenants against any suit, claim, loss, accident, judgment, fine, injury or damages, including reasonable attorney’s fees. This indemnification shall continue in full force and effect during and after the term of the rental for such causes arising during the term of the rental.
